1. Open Meeting

3. JTC Chair Discussion and Recruitment

Mr. Roux announced that PVPC will continue as interim JTC Committee Chair until a replacement is found for the currently vacant Chair. Mr. Roux stated the members are asked to reach out to PVPC staff if they would like to nominate another member or self-nominate. Mr. Roux stated that staff had sent out an email nomination request, to date we have not received any nominations.

Mr. Roux asked the JTC members to consider the opportunity of serving as the Chair of the JTC Committee and to contact Andrew McCaul if they are interested in the position or know of someone who might be interested so that this vacancy can be filled in the near future.

5. <u>Coordinated Public Transit – Human Services Transportation Plan (CPT-HSTP)</u>

PVTA Director of Operations Paul Burns explained that the goal CPT-HSTP is to improve transportation services for persons with disabilities, older adults, and individuals with lower incomes. This is done by identifying existing gaps in services and providing a framework for project development. The CPT-HSTP provide various entities with a process for access FTA funding programs. Staff acknowledged that the plan was developed during the pandemic and that once ridership returns to an acceptable level, the plan may need to be updated.

Mark Cressotti, the Engineer for the City of Westfield, asked if the plan included the return of service to the Western Mass Hospital on East Mountain Road. Mr. Burns indicated that due to vertical and horizontal clearance issue at the train underpass it was not possible to return bus service to the hospital. Mr. Burns explained that PVTA was exploring other options including dial a ride or a shuttle to link the Hospital to the regular fixed route service.

Mr. Roux asked for a motion to recommend that the Metropolitan Planning Organization (MPO) released the CPT-HSTP for the required 21-day public review period.

6. FFY Unified Planning Work Program (UPWP) Development

PVPC Principal Planner Gary Roux noted that at the last JTC meeting in March, he had stated that the FFY 2023 Unified Planning Work Program (UPWP) will run from October 1st of this year to September 30th of next year and will share the same development and endorsement schedule as the Transportation Improvement Program (TIP). Mr. Roux explained that the UPWP layouts staff planning activities for the next Federal Fiscal Year. Mr. Roux explained the 2023 UPWP includes the 2024 Regional Transportation Plan (RTP).

Mr. Roux then spoke about tasks related to planning emphasis areas and he reported those planning areas as Tackling the Climate Crisis – Transition to a Clean Energy, Resilient Future; Equity and Justice40; Complete Streets; Public Involvement; Strategic Highway Network; Federal Land Management Agency (FLMA) Coordination; Planning and Environment Linkages (PEL); and Data in Transportation Planning. Mr. Roux noted that all these related tasks will be addressed although extra planning may be needed for the Strategic Highway Network.

Mr. Roux indicated that a draft UPWP will be presented at the April JTC meeting with a request for a 21-day public review and comment period. Then the UPWP will be presented at the May MPO meeting for endorsement.

Mr. Roux asked for a motion to recommend that the Metropolitan Planning Organization (MPO) released the DRAFT FFY 2023 UPWP for the required 21-day public review period.
