#### Open Meeting

The November 8, 2023, virtual Pioneer Valley Planning Commission Joint Transportation Committee meeting was called to order at 10:03 a.m. by JTC Chair William Dwyer, who welcomed everyone in attendance. Roll call was taken, and there was a quorum.

## 2. Minutes of the Commission Meeting of October 11, 2023

The Chair noted that the minutes of the October 11, 2023, PVPC JTC meeting were not available.

### 3. FFY 2024-2028 Transportation Improvement Program (TIP) Amendment

Mr. McCaul shared the following three amendments to FFY 2024-2028 TIP:

- Cost increase Project 612106 Springfield / Chicopee Interstate Maintenance and related work on I-91 and I-391: Increase from \$15,900,816 to \$23,667,942;
- Add Springfield Safe Streets for All (SS4A) funding: \$15,012,800;
- Add \$75,000 to the CMMPO (Central Massachusetts Metropolitan Planning Organization) for the purchase of a hybrid van for use by the Quaboag Community Development Corporation.

Mr. Dwyer asked for a motion to recommend the MPO (Metropolitan Planning Organization) to endorse the amendments.

MOVED BY BEN MURPHY, SECONDED BY DAN BANISTER, TO RECOMMEND TO MPO TO ENDORSE THE PROPOSED AMENDMENTS. A ROLL CALL WAS TAKEN, AND THE RECOMMENDATION WAS APPROVED UNANIMOUSLY. There being no questions, Mr. Dwyer moved to take up Item 4 of the agenda.

# 4. FFY 2020 FHWA Urbanized Area Boundary Update

Mr. Roux provided an update on the changes to the urbanized area boundaries based on the 2020 census. Comments on the proposed changes were submitted to MassDOT for review and endorsement by the MPO in November 2023.

There being no questions, Mr. Dwyer moved to take up agenda item 5.

### 5. JTC Participation and Recruitment

Members were reminded that in order to be eligible to vote on the JTC, they must have an appointment from their chief elected official. It was noted that there were vacancies in several municipalities and a need for active membership on the Committee. Ms. Hosea-Abbott offered to help recruit members to fill the vacancies on the JTC. It was suggested that if someone knows of potential candidates, they can forward their information to the appropriate authorities for appointment. In January 2024, a letter will be sent out to chief elected officials, PVPC commissioners, and current Committee members to provide information on the upcoming TIP update and to request updates on membership or contact information. It was suggested that tracking membership and highlighting communities not represented in the minutes could help focus outreach efforts to fill vacancies.

There being no questions, Mr. Dwyer moved to take up agenda item 6.

### 6. Other Business

Ms. Johnson informed the group about the upcoming World Day of Remembrance on November 19, 2023, where victims of road fatalities are honored. An event was planned in Springfield, and attendees were invited to participate and raise awareness about the importance of road safety.

The Chair confirmed that there will be a meeting on December 14, 2023, and reminded attendees to mark their calendars.
